

ST. GEORGE CHILDREN'S CENTER
SCHOOL AGE PROGRAM ENROLLMENT AGREEMENT

The policies of the Center are as follows:

Fees:

A \$20.00 registration fee is required on enrollment and a \$15.00 re-registration fee is due annually thereafter.

The cost for a full week of before and after school care is \$85.85

The cost for a.m. **only care is \$47.70** per week.

The cost for p.m. **only care is \$52.00** per week.

The amounts are due each week, including those weeks involving Statutory holidays and P.A days, from September – June.

The cost for a **full day** of care is **\$36.50** per day (remember to pack a lunch, two snacks will be provided by the Center)

If you pay **full time** rates, an extra **\$19.30** is due for a full day of care.

If you pay **before** school care **part time** rates, an extra **\$26.90** is due for a full day of care.

If you pay **after** school care **part time** rates, an extra **\$26.00** is due for a full day of care.

Post-dated cheques are due in advance for a 2 week period, due at the beginning of the school year.

A \$40.00 charge will be due for all returned cheques.

Financial credit of time replacement is not granted due to sickness, inclement weather or any other reason.

Rate are subject to change with one month's notice.

Program Sessions:

Regular program sessions are 7:00 to 8:30a.m. and 3:05 to 6:00 p.m.
(COVID -19 hours are till 5:30)

Please note that a charge of \$1.00 per minute is levied after 6:00 p.m.

Your child will need written permission from you if they wish to leave the program before 8:30 a.m. or to arrive after 3:10 p.m.

Age Limit:

This program is limited to children entering grade 1 up to the age of 12.

Health and Safety:

The Center reserves the right to refuse the acceptance of an unwell child. Particularly those who are in an infectious state. Please understand that this is as much for your child’s protection as it is for the other children.

It is preferred that only the parent pick up the children, but in the event that you may be unable to, you must provide written notice to the Center in advance as well as the person picking up must provide picture I.D. or the child will not be released.

It is the parent/guardian’s responsibility to keep the Center informed of any changes from the original information given (change of address, home and work, new phone numbers or contacts)

The Center will not be held liable for any extenuating circumstances which may arise due to lack of updated information.

It is the parent’s responsibility to make sure that their child is presented to the teacher on arrival and that the teacher is aware that you are removing your child at pick up.

Parents must call if your child is not going to be in attendance.
